



LEADERSHIP MESSAGE

This year RCEDC celebrates 40 years of economic development services in Racine County. RCEDC was established in 1983 at a time when the US was struggling with high unemployment, mass layoffs and rising interest rates, resulting in business closures at an unprecedented rate.

On February 25, 1983, over 100 Racine County residents came together at the Wingspread Conference Center to discuss Racine County's troubled economy. The goal of the conference was to bring together community leaders from business, labor, and government to develop a strategy to stimulate economic development in Racine County. The situation was grim as summarized by then Racine County Executive Len Ziolkowski, who shared that "During the last 10 years, our economic decline, as measured by unemployment, real personal income, and failure rate of business has been alarming." The participants were assigned to discuss six different aspects of the local economy, including (1) employment training, (2) tourism, (3) industrial attraction, (4) industrial retention, (5) business and community promotion, and (6) new development. The concluding remarks from the conference attendees favored the creation of an organization that would address the economic development needs on a county-wide basis.

Now 40 years later, several of these historical strategies continue to influence the annual strategic plans adopted by RCEDC's Leadership Council. The primary focus remains to increase the local tax base and create employment opportunities through the provision of technical and financial assistance to private businesses. These objectives are reflected throughout RCEDC's work plans.

In 2022, RCEDC's Board of Directors approved an impressive 105 projects aimed at promoting economic growth in the county. These projects varied in scope and size, ranging from small grants of \$1,700 to large development initiatives that involved over \$95 million in private investment. The completed projects are expected to total nearly \$289 million in private investment and \$125 million in new construction. Furthermore, these projects are expected to result in 544 jobs created and/or retained.

On behalf of RCEDC volunteer leadership and RCEDC staff, we want to express our gratitude to our community leaders, private businesses, contributors, and partners for allowing us to complete another successful year.

Local lenders and businesses understand the importance of retaining cash for operations, especially during uncertain economic times. To aid in this effort, many are turning to the loan programs offered by the Racine County Economic Development Corporation. One of the key advantages of RCEDC's loan program is the low 10% down payment requirement, making it easier for businesses to access the capital they need while maintaining a healthy cash flow. In 2022, RCEDC approved 105 projects, with nearly half of them being to ethnic-minority or womenowned businesses.

Leadership Programs

RCEDC's **CEO** Roundtable and Living as a Leader programs are designed to provide guidance and support to both existing and future leaders. The CEO Roundtable program brings together CEOs and business leaders from various industries to share insights, challenges, and best practices in a confidential and collaborative environment. Through this program, participants can build strong relationships with other leaders, receive valuable feedback, and gain new perspectives on critical issues facing their businesses. The Living as a Leader program helps emerging leaders develop essential leadership skills such as communication, conflict resolution, and decision-making. Both programs provide an excellent opportunity for leaders to learn and grow, ultimately leading to their success and the success of their organizations.


